A. Peace Church – Dan VanKalker presents proposal for Professional Civil Engineering Services for a Feasibility Study by Progressive and FCC Construction. The feasibility study would outline the cost of the design, construction and continued maintenance related to the expansion of the DLSA wastewater lagoons in order to service Peace Church as well as other residents of the township. The

cost of the study is \$11,500.00. Peace Church requests the cost be shared 50/50 with the township. The study would look at expanding the current system. The cost of hooking into the expanded system would be covered by Peace Church while the expansion of the system would be shared between Peace and DLSA. The board requests this information be presented to the Duncan Lake Sewer Authority. If the DLSA approves the cost of the study, then they would approach the township board with a recommendation.

B. Dana Yarger – Barry County COVID-19 Update – Proposes TTES dedicate one of two ambulances to the service of transporting COVID-19 patients from Pennock to Zeeland Hospital or Mercy Big Rapids.

- TTES pays fuel, preparation of ambulance, restocking of supplies and personal protection equipment as needed in the event of transport of COVID-19 patients.
- Pennock, Zeeland or Mercy Big Rapids pays medics wages and provides worker's compensation coverage as usual for its employees.
- Mileage will be paid to TTES if ALS provider is from another agency than TTES.
- Will jointly develop a 24 hour on-call schedule.
- See CODIV-19 transfer vehicle Prop 1 provided by Yarger for further details.
