### 7. COUNTY REPORT:

Jon Smerker:	Smelker spoke on the spongy moth concerns around the county. They will look at if they will become a bigger issue in the coming year. He went on to announce a job opening for Deputy Director of IT for GIS. He stated that there will be a

	public hearing and voting tomorrow for the Resolution of the Brownfield Development TIF. He invited the board members and members of the public to come and speak. Tomorrow there will also be a meeting to vote on the renewal of the transit millage.
Board Response:	Schaefer said they had questions on their resolution, they had wanted to talk with their attorney, but he unfortunately was out of town. He did tell them that it would be all right if they decided to move that resolution to next month's meeting. Smelker said that as he is now, he is a no vote. He said he has spoken to Thornapple Township constituents, and there were only two people for it, and the rest were against. He asked if Thornapple Township would be getting their EMS money. Eric replied they would, it would not be part of the housing TIF. He clarified that if there is a housing crisis in Thornapple Township, it should not be solved on the backs of Emergency Services. Getty added that there will be a County Admin interview next Friday, and then a second interview the following week.

#### 8. RESERVED TIME:

Fire Chief Bill Richardson stated that to maintain control over the station, there should be at least 8 Officers, so there will need to be promotions.

- **A.** Pattrick Jansens started working at the fire department in September of 2003 and became a full-time employee September of 2022. He began training officer February of 2023. He has done months of training and took a two-and-a-half-hour test for the opportunity of becoming Deputy Chief. Pattrick finished on top; they were impressed by his attention to detail. He has gotten their ISO rating down, and has taken over maintaining the Ambulances, with a fourth ambulance on its way. He received three bugles as Deputy Chief.
- **B.** Jason Preslar started in September of 2011. He oversees the building and grounds. He has been an excellent help with his knowledge of construction. He is our top officer responder; he has had fifty-two responses this year. He is looking forward to completing Fire Officer 3 and was promoted to Captain.
- C. Joe Johnson began working at the fire station in March of 2016. He started and continues to oversee the EMT classes. Fire Chief Richardson is Johnson's helper for the EPC and PHTLS classes.

Three recruit firefighters became probationary firefighters.

- D. Kevin Bull is a paramedic and registered nurse and has gone through fire school twice.
- E. Dade Landon also went through fire school twice. He comes in excited and ready to train and has been a great resource.

- **F.** Chase Maslonka started in September of 2023 and has gone through EMT school. He is one of the top responders.
- **G.** Eric Shaefer administered the oath of office to the following members: Pattrick Jansens, Jason Preslar, Joe Johnson, Chase Maslonka, Kevin Bull and Dade Landon.
- **9. EMERGENCY SERVICES REPORT:** Chief Richardson gave a summary of activity over the last month, thanked the board members for the opportunity to serve the community over the last two years and said that he was continuing to improve the ISO score so that insurance costs would decline for commercial and residential property owners.

#### 11. NEW BUSINESS:

A. Request for an OWL meeting camera and perch: Eric Schaefer explained that the OWL is a camera that can record our Township Board meetings and Planning Commission meetings. The Village has a similar camera, which is voice and audio sensitive, so it will turn to who is speaking. The whole purchase, including the camera and its perch would cost not to exceed \$1,000, and would come out of GL number 101-265-970.000. DeMaagd asked if it was battery powered. Eric replied that it is not, and the room may have to be rearranged, as the OWL will have to sit in front of the desk. It has a panorama view that will zoom on who is speaking, and that the video could be uploaded to YouTube if desired.

**B.** Request for 10-800mhz pagers: Chief Richardson said they would like to get ten more of the 800mhz pagers. They have been trying them out and have been using the VHF pagers at the same time. Richardson explained that Hastings had been doing it this way, and then switched completely over to the 800mhz. They switched completely because using both types lock up consoles, of which he was not aware. The options are to switch back to the VHF until the tower is up and running, and then move to the 800mhz, or switch over now. DeMaagd asked if they work well. Chief Richardson replied that they work better than the VHF, and they notify when they are not online, while the VHF do not. The tower goes up in November, and there should be better signal consistency. He would like to use any remaining grant funding.

**D.** Approval of a temporary website: Chief Richardson said the website would be temporary, as an opportunity for taxpayers to see where their money goes. It would cost about the same as 3 months of Pixelvine for the Thornapple Township website. Selleck asked if all the questions from the request before were answered. Bouchard stated that it was tabled before. She said they were finding a better way for the burn permits to be filled out through the website. Most of the information they want to put on this new website is already on or could added to the Thornapple Township website. It should be all on one website. She is against the temporary website. Rairigh added that she had concerns about misspellings and link issues on the temporary website. Chief Richardson said it was up, but not searchable. Rairigh stated that she would prefer if the Township website would hold the information. Eric agreed and said the information should be given to Pixelvine to put on the Township website. Chief Richardson said he did not mean to confuse the board or go against their wishes, and that it was a misunderstanding on his part. He also mentioned that he said if he had to, he would pay for it out of pocket, but not that he had already

E. Request for professional development: Chief Richardson explained that this would be a "Blue Card Incident Command Training" that is a 2-3 day class, going over different scenarios and situations. Caledonia offered to split the cost of a "Reading the Smoke" class. They would be inviting firefighters from other communities as well. Selleck asked for specifications on what Blue Card training is. Chief explained that it has its roots in military training and provides instruction for incident commanders so they can practice making decisions in various emergency operations.

- **A.** Administration (Schaefer, Bouchard, Ordway) Schaefer explained they will be finding a new Deputy Clerk soon.

## 13. SECOND PUBLIC COMMENT PERIOD:

- A. Curt DeKam He stated that he is not in favor of the TIF. He feels the state should not be subsidizing the risk for the developer and asking the community to carry the burden.
- B. Commissioner Catherine Getty- Getty said she had spoken out against this project from the beginning. She believes not enough people are coming to the meetings, so they are not hearing the opinions of the Village taxpayers, who they are relying on to fix the housing crisis. She wanted to convince the Village and the DDA to deny the project. The Village passed it unanimously, and the DDA passed it by a slim margin.

- C. Mynda Lorenz- Is concerned about the speed limit on State Rd. She believes it should stay lower by Otto's Turkey Shop. She believes it should be 45 instead of 55.
- **D.** Randy Eaton He said the distance between the double yellow line on Whitneyville Road to the white line on the edge of the road is different than on Finkbeiner Road. This makes the lanes on Whitneyville Road narrower than Finkbeiner Road.
- E. Amy Brown She thanked the board members and emergency services staff for the opportunity to work with them over the last four and half years.

Kim Selleck (Trustee) – Selleck said congratulations to those who received promotions in and thanked them for their work. He feels they are one of the pillars of the community.
